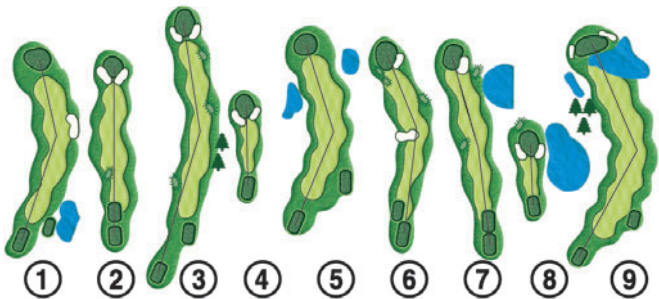

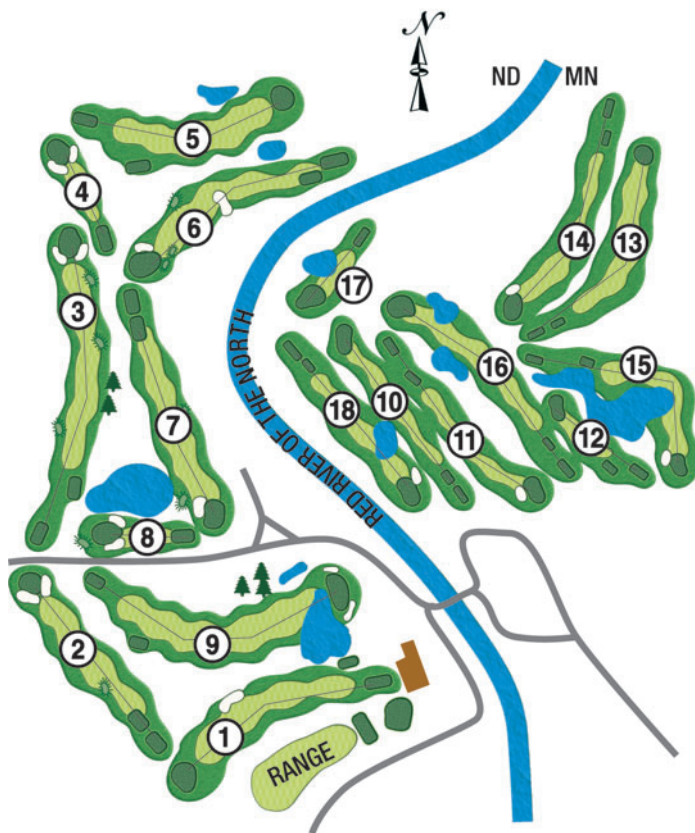

- U.S.G.A. rules govern play. The embedded ball rule is in effect through the green.
- Out of bounds is defined by white posts and perimeter fences.
- Water hazards are marked with red stakes designating them as lateral water hazards.
